



## 2021 Participant Registration

**Welcome to Willow Creek Ranch, Inc.!** WCR strives to provide a safe environment for all of our participants and requires all participants, families, guests and volunteers abide by our safety rules and policies. Although we plan to have a normal season, the nation-wide pandemic (COVID-19) still exists and we remain mindful of the impact on the participants and services of WCR. Safety and sanitation procedures are still in place. We are committed to serve our participants, but please remember that federal and state mandates may require a suspension of services.

WCR offers three programs for Equine Assisted Learning: Horsemanship, Learning and Therapy. *WCR Policies and Safety Rules* have been provided to you and cover much of the information you need to become a participant.

It is very important we receive your signed acknowledgment of receiving and reading the *WCR Policies and Safety Rules*, other participant forms, and fees as soon as you have been confirmed to participate at WCR. Participants will not be allowed to begin lessons without all required paperwork and fees paid.

### Eligibility for Horsemanship program

There is an inherent risk of equine activities (Wis. Statute 895.481). There are many factors that are involved in determining eligible participants including, but not limited to, the safety and appropriateness of the rider, horses and volunteers. Please review the *WCR Policies and Safety Rules* for eligibility for the Horsemanship program, including weight limits.

### Fees

Our participant lesson fees represent only about 30% of what it actually costs to provide each client with the benefits of equine assisted services of Horsemanship and Learning. The other 70% comes from fundraisers and donations from various sources. If personal circumstances would allow you to make a donation over and above our standard enrollment fee, it will be considered a tax deductible donation and will help us fill the gap in funding.

Billing County and State Agencies: If you or your child has a case with county funders or iLife/IRIS, submit appropriate authorization forms prior to the first lesson and WCR will submit billing forms to the funder for the approved amount of lessons.

Previous participants from 2020: There is a non-refundable registration and processing fee of \$20.00 for the year. No full evaluation/assessment is required, but we will have a review for any changes that have occurred during the off season or skipped sessions. In addition, other annually-required forms must be completed and returned.

New participants: All new participants must have an evaluation with a PATH Intl. certified therapeutic riding instructor. If a former participant has been away from the program for more than a year, he/she may be considered a new participant. Fee is \$35.00.

Group Horsemanship or Learning Lesson: the fee for one 4-week session is \$120.00.

Private Horsemanship or Learning Lesson: the fee for one 4-week session is \$160.00.

### WCR 2021 RIDING and Equine Assisted Learning (EAL) Sessions.

Please see the attached 2021 schedule of lesson times, days and dates. Lessons for 2021 are scheduled for 4-week sessions. You may register for each session separately or for the whole season.

Horsemanship and Learning lessons are 45 minutes of interaction time and may include ground work, groom or learning about the horse. If fees and paperwork are not received at least one week before the start of your session, your time may be released to another participant.
